### Terms& conditions: -

1. The Internet service provider (ISP) must be registered in India as Limited company/ Sole proprietorship under relevant acts/Udyam registration/ DIC registration. Copy of the certificate to be submitted along with quotation.
2. They have to enclose copy of valid appropriate license of class A/B for distribution of internet service along with the quotation.
3. Copy of GST, PAN certificate to be submitted along with Bid.
4. Installation should be completed within 10days after issuing of work order.
5. Installation and commissioning charge will be paid after successful installation and recurring charge will be paid quarterly after receiving of invoice.
6. The contract will have a validity of three years from the date of installation & subscription.
7. Minimum 3 years past performance from at least 3Govt. organization providing minimum 50MBPS /5 different organizations providing minimum 100MBPS internet service should be attached with bid documents (copy of work orders to be enclosed).
8. ISPs should have local office in Odisha and nearby service centre at Nayagarh.
9. The service shall be provided 24x7 days in a week. The ISP should have own manpower & technical team for support in Nayagarh for any down time.
10. The response time for attending the fault will be one hour after they are reported. The ISP will rectify the faults within 12 hours, failing which, the ISP will make temporary arrangement.
11. Minimum 8 nos of static IP to be provided for internet service.
12. Bidder/ ISP have to arrange repair & maintenance within above contract period failing which the engagement shall be terminated or payment shall be reduced by the no of days or part thereof, for which the service remained down.
13. The rate quoted for complete installation of internet should be competitive and all detailed component, if any required, to be mentioned clearly with specific rates and GST there on.
14. If the service will be found unsatisfactory, the contract of ISP will be terminated and same service will be provided to second deserved ISP.
15. The initial engagement shall be for one year and may be renewed for one more year at a time for maximum up to 2 years, depending on satisfactory performance of the vendor in providing service and also depending upon availability of funds or change of policy of Govt.
16. In case of non-renewal at the expiry of the one-year engagement, the engagement will be deemed to be terminated.
17. Submission of Quotation by the bidder shall be treated as that they agree to all terms & conditions mentioned in the quotation call notice.
18. All the disputes will be subjected to the jurisdiction of courts of Odisha as applicable.
